1. Convene Regular Meeting / Pledge of Allegiance / Self-Introductions

Chair Cloven called the meeting to order at 9:01 A.M.

4. AUDIT SERVICES FOR TRANSPAC.

Commissioner Ross entered the meeting.

Mr. Todd made a brief presentation.

On a motion by Commissioner Haskew, seconded by Commissioner Obringer to authorize staff to initiate an informal procurement process to collect proposals for TRANSPAC audit services that will result in a recommendation on the procurement at a future TRANSPAC Board Meeting by unanimous vote of the members present (Cloven, Noack, Haskew, Carlson, Obringer, Ross).

5. REGIONAL COORDINATION WITH PARTNER AGENCIES.

Mr. Todd introduced the item and commented that regional coordination with partner agencies is listed as a standing priority in the FY 2023-2024 Workplan. Mr. Todd noted that a meeting with TRANSPLAN was held in 2021 and that staff is proposing to meet with SWAT next. Mr. Todd commented that he spoke with staff from SWAT and shared potential topics. SWAT staff suggested an October or November meeting timeline and that they would bring the meeting proposal to their Committees to get feedback. It is also proposed that the meeting be held separately from the regular TRANSPAC meetings.

Mr. Todd also commented that the meeting could potentially be held in the SWAT area as it may be of interest to the Board to visit the autonomous shuttle at Bishop Ranch.

Commissioner Noack commented that visiting the Bishop Ranch autonomous shuttle would be a good idea whether it is with SWAT or a separate visit. Commissioner Noack further commented that there will soon be an autonomous shuttle at Rossmoor and in Martinez and it would be good for the Committee to see how it works. Commissioner Noack further noted Pleasant Hill Road as a potential topic of discussion.

Commissioner Carlson noted the discussion of bus on shoulder at CCTA and the impact it will have in both the TRANSPAC and SWAT areas.

Commissioner Noack further commented that the integration of transit services was a topic of discussion at MTC and there are plans to put forward a regional transportation measure in 2026. In the discussion, it was noted that there will need to be a transformation in the way transportation services are delivered for the measure to pass.

Commissioner Haskew requested that the meeting be held in the first quarter of 2024. Commissioner Noack agreed with the timeline and commented that the timeline could better align with the progress of the Concord Naval Weapons Station. Commissioner Obringer noted that May would be ideal if the Naval Weapons Sation is a topic of discussion.

6. TRANSPAC CCTA REPRESENTATIVE REPORTS.

Administration and Projects Committee (APC) meeting update:

Commissioner Noack noted that the Town of Moraga, St. Mary's Road Multimodal Safety Improvements Project was awarded STIP funding this cycle. Commissioner Noack noted that Pleasant Hill was a close second and third in line for funding but only one project was recommended for programming. Commissioner Noack further commented that Diane Burgis representing Brentwood was appointed to the San Joaquin Joint Powers Authority (SJJPA) and Aaron Meadows, representing Oakley was appointed as the alternate. Commissioner Carlson added that Measure X funding was allocated to East County.

Commissioner Noack highlighted the following topics from the MTC meeting:

- 1. Transit Oriented Communities development policy.
 - Cities will have to comply with the policy to receive OBAG funds in the future.
 Commissioner Noack noted that there are not a lot of developments near transportation in Contra Costa and that there are potential conflicts with RHNA.
 Commissioner Noack noted she plans to meet with MTC staff to get further clarity on the policy and implications for central county.
- 2. Regional Bond Measure.
 - The measure, slated for 2026, was discussed as an opportunity to encourage the integration and transformation of transportation service delivery.

3. Clipper 2.0 system

Clipper 2.0 will be launched next summer. Commissioner Noack asked MTC staff
if there will be improvements in accessing senior and youth Clipper cards and
noted that she will discuss this further.

Summary of Issues	Beginning in March of 2020, the Governor issued a series of Executive Orders relaxing certain provisions of the Brown Act in response to the COVID-19 pandemic. Those orders allowed local agencies such as TRANSPAC to conduct their public meetings remotely. On June 11, 2021, the Governor issued an Executive Order that rescinded the aforementioned relaxations of the Brown Act, effective September 30, 2021. On September 15, 2021, the Governor signed into law AB 361 which essentially continued the Executive Orders that eased certain Brown Act provisions, allowing for remote meetings without observing the normal Brown Act rules.					
	On October 14, 2021 the TRANSPAC Board adopted Resolution 21-01 proclaiming a local emergency, ratifying the proclamation of a State of Emergency, and authorizing remote teleconference meetings of the legislative bodies of TRANSPAC pursuant to the Brown Act provisions under AB 361. This resolution also authorized the 30-day renewal to be approved at subsequent meetings by minute order.					
	On February 28, 2023 the Governor ended the state wide COVID-19 state of emergency. Contra Costa Health Services (CCHS) released revised recommendations for public meetings (dated March 27, 2023) and no longer recommends remote meetings of public bodies but recommends social distancing (when feasible) and masking during periods of high COVID-19 transmission.					
	At the May 11, 2023 TRANSPAC Board meeting, the Board authorized hybrid TRANSPAC Board meetings pursuant to the Brown Act provisions under AB361 and consistent with the Contra Costa Health Services' recommendation for social distancing (when feasible). By way of this action, Board members will attend in-person with a remote meeting option for members of the public. Other TRANSPAC bodies including the TRANSPAC TAC, special and/or ad-hoc committees will continue meeting virtually. This action also requires that the TRANSPAC Board					

reconsider the circumstances of meetings of TRANSPAC every 30 days per AB361.

Recommendation

Reauthorize the continuation of remote meetings of the legislative bodies of TRANSPAC pursuant to the Brown Act provisions under AB361 through November 13, 2023. By way of this action, TRANSPAC will conduct in-person meetings with a hybrid component for public participation for regular TRANSPAC Board meetings. Other TRANSPAC bodies including the TRANSPAC TAC, special and/or ad-hoc committees will continue meeting virtually.

There is no immediate fiscal impact.

A. Recommendations for safely holding public meetings, gatherings, and business meetings (revised March 27, 2023)

Background

Beginning in March of 2020, the Governor issued a series of Executive Orders relaxing certain provisions of the Brown Act in response to the COVID-19 pandemic. Those orders allowed local agencies such as TRANSPAC to conduct their public meetings remotely. On June 11, 2021, the Governor issued an Executive Order that rescinded the aforementioned relaxations of the Brown Act, effective September 30, 2021. On September 15, 2021, the Governor signed into law AB 361 which essentially continued the Executive Orders that eased certain Brown Act provisions, allowing for remote meetings without observing the normal Brown Act rules. AB 361 has a requirement to reconsider the circumstances of the State of Emergency every 30 days and determine whether the State of Emergency continues to directly impact the ability of the members to meet safely in person, or State or local officials continue to impose or recommend measures to promote social distancing.

On October 14, 2021 the TRANSPAC Board adopted Resolution 21-01 proclaiming a local emergency, ratifying the proclamation of a State of Emergency, and authorizing remote teleconference meetings of the legislative bodies of TRANSPAC pursuant to the Brown Act provisions under AB 361. This resolution also authorized and directed that the TRANSPAC Subcommittees will also continue to meet remotely, and that the resolution would be renewed within 30 days, consistent with the requirements of AB 361, if TRANSPAC desired to continue meeting under the modified Brown Act.

Governor Newsom ended the State level COVID-19 State of Emergency on February 28, 2023, which was the initial impetus to authorize remote meetings under the Brown Act Provisions of AB 361. On March 27, 2023, Contra Costa County Health Services (CCHS) revised the "Recommendations for Safely Holding Public Meetings", which no longer encourages online meetings except where the COVID-19 transmission is medium or high and would impact high-risk individuals. The guidance continues to encourage social distancing, including six feet of spacing between individuals when feasible and encourages masking when transmission is high.

At the May 11, 2023 TRANSPAC Board meeting, the Board authorized hybrid meetings of the TRANSPAC Board and Committees under the provisions of Assembly Bill 361 (AB361) and consistent with the Contra Costa Health Services' recommendations for social distancing for public meetings (where feasible). Through this action, Board members will attend in-person with a remote meeting option for members of the public. Other TRANSPAC bodies including the TRANSPAC TAC, special and/or ad-hoc committees will continue meeting virtually. This action also requires that the TRANSPAC Board reconsider the circumstances of meetings of TRANSPAC every 30 days per AB361. This approach is consistent with the CCTA Board's approach to the AB361 legislation. Staff will continue to monitor Contra Costa Health Services recommendations and maintain communication with CCTA staff on AB361 implementation.

It is requested that the TRANSPAC Board reauthorize the continuation of remote meetings of the legislative bodies of TRANSPAC pursuant to the Brown Act provisions under AB361 through November 13, 2023 as outlined above.

Recommendations for safely holding public meetings, gatherings, and business meetings:

As we enter this new phase of COVID-19 we have more tools available to mitigate transmission of COVID-19 and decrease the chance of severe disease. These tools remain important and should be taken into consideration when holding public meetings or other gatherings. Information about local COVID-19 indicators can be found at CDC county community level and https://www.coronavirus.cchealth.org/data-summary.

As the COVID-19 public health emergency ends, the following are recommendations to minimize the risk of COVID 19 transmission during a public meeting.

- Allow options for individuals who may be at higher risk to attend and participate via a call-in
 or an internet-based services option. This is good practice generally, no matter the COVID19 transmission rate, but is particularly important when community level is medium or
 high.
- Recommend indoor masking, particularly if county COVID-19 community level is medium or high, as noted in CDPH masking guidance: https://www.cdph.ca.gov/Programs/CID/DCDC/Pages/COVID-19/guidance-for-face-coverings.aspx.
- 3. Recommend self-symptom screening no matter the COVID-19 county community level and encourage messaging that continues to reinforce that individuals not go into common or public indoor spaces when not feeling well in order to reduce disease transmission.
- 4. Recommend social distancing (six feet of separation between individuals), when feasible.
- Consider holding public meetings, gatherings, or business meetings outdoors, when county COVID-19 community levels is high. If unable to host outdoors, consider ways to <u>increase</u> <u>ventilation and flow</u> of the indoor space to reduce the risk of COVID-19 transmission while indoors.
- 6. Encourage attendees to remain up-to-date on their COVID-19 vaccine no matter the county COVID-19 community level.

REMINDER: Full Closure of Southbound I-680 in Pleasanton between I-580/I-680 Connector and Koopman Road the Weekend of November 3-6, 2023 (In Case of Rain, Closure Will be Rescheduled)

PLEASANTON / ALAMEDA COUNTY – Caltrans is scheduled to close southbound Interstate 680 in Pleasanton between I-580/I-680 Connector and Koopman Road on Friday, November 3 through Monday morning, November 6, 2023.

During the closure, contractor will replace a portion of the existing deteriorated roadway with new pavement on southbound I-680, between I-580/I-680 Connector and Koopman Road. This work will repair deteriorating existing pavements and enhance motorist safety while reducing the number of nightly closures needed on the project.

The I-680 freeway will be closed in the southbound direction between I-580/I-680 Connector and Koopman Road from 9:00 p.m. Friday, November 3 to 4:00 a.m. the following Monday, November 6.

In the case of rain or unanticipated developments, the closures will be rescheduled and the public will be notified.

Portable changeable message signs will be placed prior to closure advising motorists of this closure and will remain in effect throughout the weekend while work is being performed.

Northbound I-680 will remain open and will not be affected by the closure.







Caltrans is aware that the closures will impact the motoring public and measures are being taken to minimize inconvenience. Caltrans thanks the motoring public in advance for your patience as we work to improve I-680.

California Highway Patrol officers and message signs will be on hand to guide motorists. Detours for the closures are as follows:


- 1. Motorists driving west on Interstate 80 in Vacaville and Fairfield will remain on I-80 to southbound I-880.
- 2. Motorists on southbound I-680 near the Benicia Bridge can take I-780 west to I-80 to southbound I-880.
- **3.** Motorists on southbound I-680 in Concord can take SR-4 to I-80 to southbound I-880.
- **4.** Motorists on southbound I-680 in Walnut Creek can take SR-24 to I-80 to southbound I-880.
- **5.** Motorists on Southbound I-680 in Danville take westbound I-580 to SR-238 to southbound I-880.
- **6.** Motorists on Southbound I-680 in Danville take eastbound I-580 to SR-84 to southbound I-680.
- 7. Motorists on westbound I-580 coming from Tracy can exit onto southbound SR-84 and get back on southbound I-680 just south of Calaveras Road near Sunol.
- 8. Motorists on westbound Sunol Boulevard can only take northbound I-680. (Access to Southbound I-680 is restricted in Pleasanton City and Sunol City)
- 9. Full Shutdown of southbound Foothill Road and southbound Pleasanton Sunol Road at Castlewood Drive: Motorists on southbound Foothill can only turn left onto Castlewood Drive and only turn left again onto Pleasanton Sunol Road to northbound I-680. (Access to Southbound I-680 is restricted in Pleasanton city and Sunol City)
- 10. Full Shutdown Locations:
 - a. I-580/I-680 Connectors onto southbound I-680
 - b. Southbound Saint Patrick Way on ramp onto southbound I-680
 - c. Southbound Stoneridge Drive on ramp onto southbound I-680
 - d. Southbound Bernal Avenue on ramp onto southbound I-680
 - e. Southbound Sunol boulevard on ramp onto southbound I-680



TRANSPAC Board Meeting **STAFF REPORT**

Meeting Date: October 12, 2023

TRANSPAC is represented on the Contra Costa Transportation
Authority's (CCTA) Technical Coordinating Committee (TCC) by three (3) primary representatives and one (1) alternate. TRANSPAC is also represented on the Innovate 680 Technical Advisory Committee (TAC) which is comprised of (1) primary and (1) alternate staff member from Concord, Martinez, Pleasant Hill, Walnut Creek and Contra Costa County. Due to staffing changes, there is (1) primary vacancy on the TCC and (1) primary vacancy on the Innovate 680 TAC for the City of Pleasant Hill. The TAC is requested to recommend appointments to fill the (2) vacant primary positions.
Appoint Ryan McClain (Pleasant Hill) as a primary representative to the TCC for the term ending March 31, 2025, and as a primary representative to the Innovate 680 TAC. Recommend the appointment of Ananthan Kanagasundaram (Pleasant Hill) as an alternate representative to the Innovate 680 TAC.
 Defer the recommendation. Request alternative appointments.
There is no immediate fiscal impact.

Background

TRANSPAC is represented on the CCTA Technical Coordinating Committee (TCC) by three staff representatives and one alternate from the planning and engineering disciplines. The TCC provides advice on technical matters that may come before the CCTA. Members also act as the primary technical liaison between the CCTA and the RTPCs. The TCC reviews and comments on items including project design, scope, and schedule; provide advice on the development of priority transportation improvement lists for submittal to the Metropolitan Transportation Commission (MTC) for projects proposed under certain federal transportation acts; reviews and comments on the Strategic Plan of the CCTA; reviews and comments on the CCTA Congestion Management Program; reviews RTPC Action Plans and the Countywide Transportation Plan; and reviews and comments on the CCTA Growth Management Plan Implementation

Documents. The TCC may also form subcommittees for specific issues and meet approximately ten times a year.

Jaime Rodriguez, (Pleasant Hill), is currently the primary member on the TCC for the term ending March 31, 2025. Due to staffing changes, Ryan McClain, (Pleasant Hill) is recommended to replace Mr. Rodriguez as the primary representative.

TRANSPAC is also represented on the Innovate 680 TAC which includes (1) primary and (1) alternate staff member from Concord, Martinez, Pleasant Hill, Walnut Creek and Contra Costa County. The INNOVATE 680 TAC serves as the technical advisory body for the INNOVATE 680 Policy Advisory Committee (PAC) concerning the INNOVATE 680 suite of projects. Due to staffing changes, Ryan McClain, (Pleasant Hill), is recommended to replace Ananthan Kanagasundaram (Pleasant Hill) as the primary TAC representative on the committee. Ananthan Kanagasundaram (Pleasant Hill) is recommended to serve as the alternate representative.

It is requested that the TRANSPAC Board approve the appointments as recommended.

Background

The Measure J Expenditure Plan includes a program, line 15: Transportation for Seniors & People with Disabilities. The name generally self-describes the activities that the program funds. There is an additional program in Measure J, line 20a: Additional Transportation Services for Seniors & People with Disabilities, which provides the TRANSPAC area an additional 0.5% for these types of services. TRANSPAC is responsible for recommendations on how the Line Item 20a funds are to be used. At the end of each programming year, all funding recipients are required to submit a progress report detailing the status of operations from the previous year. The following is a summary of the progress reports received for FY 2022/2023 activities.

FY 2022-2023 Programs and Costs

Ten programs were awarded 1.2 million in funding for FY 2022-2023 – FY 2023-2024 operations. The programs provide a wide range of services and trip types, which is reflected in the range of operating and cost metrics for the various services funded. Overall, programs include volunteer and non-volunteer provided services, high level of assistance door-thru-door service as well as fixed-route service. In recent years, we have also seen the addition of Taxi

Scrip and Transportation Network Companies (TNC) services that provide flexibility beyond traditional service hours as well as a Travel Training Program.

All projects funded by the Line 20a program maintained operations throughout FY 2022-23. In some cases, there were delays in executing master agreements as well as completing invoicing. The reported causes included a lack of clarity in the agreements process and staffing shortages. TRANSPAC Staff is in communication with CCTA and the project sponsors to resolve any issues. For the upcoming programming cycle, TRANSPAC staff proposed a 120-day policy for executing master agreements. This policy is recommended to be included in the program policy document with a copy of the master agreement template for reference.

Current Line 20a funds utilized account for 37% of the approved funding available to the programs for the current 2-year cycle. Invoicing delays account for part of the lower utilization as well as staffing shortages impacting operations in the case of the City of Walnut Creek. In other cases, actual program costs are much higher than the Line 20a funds approved such as the Golden Rain Foundation/Rossmoor Greenline Route service. However, the Greenline service is operated using additional sources of funding.

Trip Costs

Of the cost-per-trip information reported, comparable Line 20a service is less than County Connection, LINK (which cost approx. \$75 per passenger in FY 2022-2023). Overall cost impacts due to COVID-19 have decreased. However, program staff have reported challenges in hiring and retaining drivers and administrative staff as well as increased fuel and equipment costs.

Trip Detail

Approximately 3,255 unique individuals in the TRANSPAC area were served by the various programs in FY 2022-23; this number increased by 58% from FY 2021-2022. Overall, the increase in individuals served speaks to both the recovery of services and increase in user participation post-pandemic. Despite this, many programs reported that the user participation has not yet returned to pre-pandemic levels and anticipate increased ridership in the near future.

One-Way Trips

In FY 2022-23, approximately 64,516 trips were provided where either the origin or destination of the trip was within the TRANSPAC area, and 49,653 trips were provided entirely within TRANSPAC. One-way trips significantly increased from FY 2021-22, a trend that is seen across all previously funded projects.

Travel Training

The Travel Training Program is managed by County Connection/CCCTA in partnership with the Center for Independent Living Resources Center of Solano and Contra Costa County. Because it is a unique program in the lineup of origin-destination transit programs, it's worthwhile to highlight some of the program milestones in the first year. In the first few quarters, staff focused on program development including the creation of outreach materials, training material, and hiring a travel trainer. In the fourth quarter, staff transitioned to hosting travel training sessions, offering presentations and participating in outreach events. Staff held 4 travel training sessions, conducted 3 travel training presentations and received 90 referrals to the program from County Connection and other outreach efforts.

Shared Trips

There were 29,921 shared trips reported in FY 2022-23. These trips include origin and/or destination points within the TRANSPAC area but are not exclusively within TRANSPAC. Some programs did not report shared trip information this past year though information was reported in the past. Staff is in communication with the project sponsors to get the most accurate information. Despite this, shared trips have more than doubled from FY 2021-22 shared trips reported.

ADA Certified/Paratransit Eligible Users

As one of the core goals of the Measure J Line 20a program is to provide cost-effective and tailored transportation alternatives to County Connection/LINK, in the last two years, staff began to request ADA participant data if available. Project sponsors reported approximately 10,523 one-way trips taken by 219 ADA eligible/certified users in the TRANSPAC area in FY 2022-23. This number is likely larger as programs such as Mobility Matters reported that most users are ADA eligible, though they do not track ADA trips explicitly. The table below includes the number of ADA participants enrolled in Line 20a funded programs and one-way trips taken by ADA eligible and/or certified users in both the TRANSPAC area and beyond.
